#### Appendix H: 2018 South Texas Floods Grant Agreement Specific Condition Report

Following the State of Texas 2018 South Texas Floods Action Plan approval on October 15, 2020, HUD issued a grant agreement to the State of Texas, which included several specific conditions. Among other things, the state of Texas is required to "submit a substantial action plan amendment upon the award of CDBG-DR funds through its method of distribution and/or competition process that identifies the entities that have received funds and the amount of each award. The substantial amendment shall also include data to identify protected classes, racially and ethnically concentrated areas, and concentrated areas of poverty, within the HUD-identified and grantee-identified most impacted and distressed areas (MIDs) and provide a meaningful analysis that describes how those identified populations and areas may be impacted by those newly funded activities."<sup>57</sup>

The Specific Conditions Report included in Amendment 1 of the Action Plan, approved by HUD on September 7, 2023, provided analysis of the projects that were funded under the Affordable Rental Program. Amendment 2 adds analysis of the projects funded under the State Infrastructure Competition to Appendix H.

The Affordable Rental Program area is comprised of three eligible Texas counties as identified by HUD and the state for DR-4377. The GLO received ten applications for a combined total of \$27,720,585 for approximately \$10.11 million in available funds. As detailed in section 5.5.3 of the action plan, the GLO issued a Notice of Finding Availability (NOFA)/ Request for Proposals (RFP) that established the application process and acceptance period, threshold criteria (including applicable building codes), selection criteria and the award process.

The State Infrastructure Competition Program area is comprised of three eligible Texas counties as identified by HUD and the state for DR-4377. As detailed in section 5.5.4, the GLO outlined scoring criteria based on factors including total damage per capita, cost per beneficiary, and SoVI score. Applicants were permitted to submit up to two applications during the application period.

The 2018 South Texas Flood eligible area and state of Texas demographics differ in a few key areas. The eligible area is 91% Hispanic or Latino, compared to the state, which is 39.3%. Because of this significant difference in Hispanic or Latino percentages, other demographics have significant differences including the percentage of Black or African Americans alone (0.42% for the eligible area and 11.8% for the state), White alone (9.0% for the eligible area and 42% for the state), and Asian alone (0.84% for the eligible area and 4.7% for the state). Also of note is the difference in poverty rate, 23.03% for the eligible area and 14.7% for the state. Due to these deviations, the most statistically sound comparison for the purposes of this analysis was to compare the projects awarded to the 2018 South Texas Floods eligible area.

The GLO reviewed the HUD Racially or Ethnically Concentrated Areas of Poverty (R/ECAP) Mapping tool which showed that three of the four cities that will benefit from the Affordable Rental Program projects overlap with a total of thirty R/ECAP census tracts for the eligible area. The GLO designed fully objective project selection criteria to select projects to be funded by the

Affordable Rental and State Infrastructure Programs. These criteria were designed to be responsive to the 2018 South Texas Floods requirements in the Federal Register notice, prioritizing High Opportunity Zones as applied to AFFH, extremely low income areas, LMI population, serving persons with disabilities beyond minimum requirements and cost-effectiveness.

The Affordable Rental Program awardees received \$10,110,000 in four awards. This program represents 13.87% of the \$72,913,000 allocated to the State of Texas for the 2018 South Texas Floods.

To date, the projects funded by the State Infrastructure Competition total \$11,510,997.36 through 12 awards. This program represents 27.0% of the \$72,913,000 allocated to the State of Texas for the 2018 South Texas Floods.

In the analysis of the resulting awards, all three of the eligible counties had applicants that were awarded projects. All four of the projects in the Affordable Rental Program across the three counties will be guaranteed to house low- and moderate-income renters, meaning the program has an LMI beneficiary rate of 100%. For the State Infrastructure Competition, all 12 projects are utilizing the LMI national objective, and have an LMI beneficiary percentage above 51%. To comply with the HUD Grant Agreement Specific Condition laid out above, the state is providing the following:

The table for protected classes statistics for each awarded project and each 2018 South Texas Floods eligible county provided specific data summaries for five of the seven protected classes (see table below). In conducting a data assessment and review for this Specific Condition, no pertinent data is available to identify the protected classes of Color and Religion at a relevant level of analysis.





#### Tx Jackson Apartments, LP - Jackson Street Apartments: Hidalgo County - \$5,000,000.00

The Jackson Street Apartments development located at 220 West Jackson Road in McAllen is a new construction with two residential buildings with a maximum of three stories each for 36 total garden style units. Because the development is on the border of both city of McAllen and the city of Pharr, the analysis below will include information on both cities. There will be one-, two- and three-bedroom units that range in size between 720 and 1,280 square feet. All 36 units will be guaranteed to house low- and moderate-income (LMI) renters, meaning it has a LMI beneficiary percentage of 100%.

The construction will be concrete slab with thirty percent of the siding being stone and the remainder fiber cement siding. The development will have 36 covered parking spaces available and 75 uncovered spaces. The units will have covered entries and patios and balconies, nine-foot ceilings, and storage rooms. The flooring will be 100% resilient covering and there will be ceiling fans in all rooms. Appliances will include microwave ovens, self-cleaning ovens, refrigerators with ice makers, and laundry equipment in each unit. The development will have full perimeter fencing, controlled gate access, barbeque grills and picnic tables along with a covered gazebo. Green building will include R-15 walls and R-30 ceilings, 14 SEER HVAC air systems, and an irrigation system with landscaping (many natural trees are present). The units will all be energy efficient.

The development site is in an urban style setting with available retail and amenities located nearby. The surrounding community has mixed housing with a manufactured home unit (MHU) facility across Jackson Street, brick single family construction scattered nearby, well developed condominiums and townhomes, and large estate style homes on Moore Street. The area has public transportation and is reasonably close to the major Lower Rio Grande Highway, but not so close as to hear significant traffic noise. Medical facilities, restaurants, shopping, food sources and drugstores are all within the immediate area.

#### **McAllen Demographics**

McAllen is a community of 141,968 residents in Hidalgo County (855,176), while the population of the 2018 South Texas Floods eligible area is 1,317,814. The median household income of McAllen is \$46,804, greater than Hidalgo County's median income of \$44,818, and greater than the 2018 South Texas Floods eligible area's median income of \$40,092. The poverty rate in the city of McAllen is at 23.05%, less than Hidalgo County's rate of 31.2%, and greater than the eligible area's poverty rate (23.03%). #### Pharr Housing Development Corporation – Camilla Court: Hidalgo County - \$3,088,000.00

Camilla Court is a new construction multifamily development totaling of eighty units on two sites, including eight residential buildings and one nonresidential building. All 80 units will house lowand moderate-income (LMI) renters, meaning it has a LMI beneficiary percentage of 100%.

The units will be constructed on concrete slabs with a stucco and masonry veneer. The complex will include two hundred uncovered parking spaces. The construction will include covered entries and balconies, nine-foot ceilings, and fire sprinklers in all units. The interiors will include ceramic tile, microwave ovens, self-cleaning ovens, a refrigerator with ice maker, and laundry equipment in each unit. 




# **Hidalgo: Project Service Areas**

#### Housing Associates of Brownsville, Ltd. - La Villita Apartments: Cameron County -\$1,456,000.00

La Villita is an existing Brownsville Public Housing Authority Complex that is located at 529 Old Port Isabel Road, Brownsville, Texas, 78521 that will be rehabilitated. The apartment complex has 12.24 units per acre with green space present within the development. All 68 units will be guaranteed to house low- and moderate-income (LMI) renters, meaning it has a LMI beneficiary percentage of 100%.

The apartment units are constructed from masonry and have covered entries and patios/balconies. Also on the complex are a community laundry room and a pool near the office. There is ample parking present. Individual units have a microwave oven, a self-cleaning oven, a refrigerator with icemaker, ceiling fans in all rooms, and laundry connections.

La Villita will replace windows and associated drywall and to remove mold and mildew in areas where water damage has occurred and repair stucco repair water has penetrated. Additionally, they will modify 29 units in order to satisfy minimum accessibility standards as well as requirements found in the current Low Income Housing Tax Credit Land Use Restriction Agreement. The scope of work also indicates that the funds will be used to upgrade all units to meet HUD Community Planning and Development Green requirements, to replace HVAC systems, appliances, plumbing features, flooring, and for unit upgrades in select units. 




# **Cameron: Project Service Areas**

#### Rural Economic Assistance League, Inc. - Casa Real II: Jim Wells County - \$566,000.00

Casa Real II is an existing apartment complex located at 325 NW Second Street, Premont, TX, 78375 that will be rehabilitated. There are 32 total units, all low income, in the complex. Four of the units are two bedrooms, 22 are one bedroom and six are studio style apartments. The structures have several connected units in each building with a front patio and a small yard in front of the buildings. As all 32 units are already for low- and moderate-income (LMI) housing, this project has a LMI beneficiary percentage of 100%.

The units are made of masonry veneer built on concrete slabs. The units are a garden style walkup layout. All of the units have ceiling fixtures, storage rooms, and warmed and cooled air in the units. Each unit has a storage unit and a sub metered utility meter. All have one bathroom in the unit.

The project includes the rerouting water during weather events throughout the property, replacement of walkways and parking areas, improved safety issues like additional lighting, relocation/rehabilitation of electrical concerns, air handlers, and improvements to the administration building and the signage.




# **Jim Wells: Project Service Areas**




### Jim Wells County: Racial and Ethnic Makeup by Block Group



### Jim Wells County: Population in Poverty by Block Group







### City of Combes – Sewer System Improvements (2018) - \$1,000,000.00

This project provides an area benefit within the City of Combes, benefitting 55.56% LMI persons, therefore meeting the LMI national objective. The project area's LMI beneficiary percentage is greater than the City of Combes' LMI percentage of 51.72%, greater than Cameron County's LMI percentage of 55.14%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

The project will make improvements to its sewer system by rehabilitating 30 critical manholes and replacing 208 manhole lids in the system. The proposed improvements will comprise of replacing existing ring and cover to prevent inflow as well has rehabilitating sanitary sewer manholes whose depth reach the ground water table and experiences infiltration. The manhole lids will be replaced with lids that provide a watertight seal to prevent inflow, while rehabilitated manholes will be coated with a sealer on key areas exhibiting infiltration. Other secondary improvements include pavement repair, regrading, site improvements, and erosion and traffic control. These upgrades and improvements will have a lasting impact on the City of Combes by mitigating the risk of public health hazards, promoting environmentally sound methods of wastewater collection and treatment, mitigating negative aspects of improper sewer disposal, and providing infrastructure to support housing and economic recovery activities.

The City of Combes Sewer System Improvements Project has a beneficiary total of 2,302 residents in Cameron County, which has 421,666 residents, while the population of the 2018 South Texas Floods Eligible Area is 1,317,814. The median household income in the project beneficiary area is \$42,249.55, greater than Cameron County's median income of \$38,758.00, and greater than the 2018 South Texas Floods Eligible Area's median income of \$40,092.00. The poverty rate in the project beneficiary area is 23.39%, less than Cameron County's rate of 28.88%, and less than the eligible area's poverty rate of 29.23%.

The project beneficiary area population is 89.66% Hispanic or Latino origin, equal to Cameron County's 89.66% and less than the percentage for the 2018 South Texas Floods Eligible Area of 91.0%. The project beneficiary area is 0.27% Asian alone, less than Cameron County's percentage of 0.66% and less than the 2018 South Texas Floods Eligible Area's rate of 0.84%. The Native Hawaiian and Other Pacific Islander percentage for the project beneficiary area is 0.00% of the population is two or more races, less than Cameron County, which is at 0.16%, and less than the 2018 South Texas Floods Eligible Area, which is at 0.14%.

Native born national origin residents from within the United States is 84.77% in the project beneficiary area, greater than Cameron County at 75.54%, and greater than the 2018 South Texas Floods Eligible Area, which is at 73.74%.

The project beneficiary area is 50.29% male, greater than Cameron County's percentage of 48.60% and greater than the 2018 South Texas Floods Eligible Area's percentage of 48.86%. The project beneficiary area is 49.71% female, less than the 51.40% of Cameron County and less than the 2018 South Texas Floods Eligible Area's female percentage of 51.14%.

The households in the project beneficiary area are comprised of 55.08% married couple families, which is greater than Cameron County's 52.25% and greater than the 2018 South Texas Floods Eligible Area's percentage of 53.08%. The percentage of households in the project beneficiary area that are occupied by married couples who have their own children in the household under 18 is 25.18%. The project beneficiary area's households are 1.01% occupied by a male householder with no spouse or partner present who have their own children in the household under 18, less than Cameron County, which is at 1.74% and less than the 2018 South Texas Floods Eligible Area's 1.41%. The current manholes suffered damages due to inflow and infiltration inundating the system. Although still functional, the inundation has left the system vulnerable to future severe weather events. The city has taken temporary measures to ensure safety of its residents; however, this does not create the stability the system needs to function in case of another flooding event.

The City of Combes housing is mixed. Much of the housing is rural (even when in a more densely populated area) and is constructed of brick or wood. The housing is generally older stock, but in a traditional format for rural housing.

### City of La Feria – Drainage Improvements (Channel Widening) - \$1,000,000.00

This project provides an area benefit within the City of La Feria, benefitting 58.26% LMI persons, therefore meeting the LMI national objective. The project area's LMI beneficiary percentage is greater than the City of La Feria's LMI percentage of 57.30%, greater than Cameron County's LMI percentage of 55.14%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

Project improvements include the installation of approximately 110 linear feet of 60-inch reinforced concrete pipe including modifications to the existing structure to accommodate the new reinforced concrete pipe. The City of La Feria project improvements also include the installation of approximately 700 linear feet along a roadside ditch on Highway 506 of concrete lining and widening of the existing drainage channel, rehabilitation of existing culverts, and all associated appurtenances. The drainage improvements will help the City of La Feria withstand future flooding events and continue to recover after the 2018 South Texas Floods.

The percentage of persons with a disability in the project beneficiary area is 15.64%, greater than Cameron County's 12.41%, and greater than the 2018 South Texas Floods Eligible Area's percentage of 12.87%.

The project beneficiary area has zero census tracts that are designated as a R/ECAP. Cameron County has a total of 33 census tracts that are designated as R/ECAPs.

There are limited houses on the side of the street where the project is planned. There are smaller homes on the other side of South Main Street near the project site that should not be negatively impacted, other than during the construction process.

Adjacent to the berms for the overall drainage and the La Feria Reservoir are a series of smaller homes with carports and some garages. These houses are brick construction, and it is a wellestablished neighborhood. There is also a mobile home unit park in the area. Also, in the benefit area are houses on the other side of South Main Street, which are generally larger brick homes. There is one estate style home that has a large, fenced yard with several other structures.

### City of Rio Hondo – Heywood Drainage Project - \$1,000,000.00

This project provides an area benefit within the City of Rio Hondo, benefitting 64.12% LMI persons, therefore meeting the LMI national objective. The project area's LMI beneficiary percentage is greater than the City of Rio Hondo's LMI percentage of 49.40%, greater than Cameron County's LMI percentage of 55.14%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

The proposed drainage improvements consist of installing sixteen curb inlets, five junction boxes, 3,645 linear feet of underground storm drainpipe system, the expansion of Heywood Street from 20 feet to 32 feet, 3,716 linear feet of curb and gutter, and restoration of pavement to original condition and all associated appurtenances.

Heywood Street was constructed to rural cross section roadway standards with no curb and gutter. Additionally, the existing drainage system in the area is insufficient in both sizing and capacity to manage stormwater. As the city is subject to more frequent and severe storm events the roadways cannot divert the storm water to the drain system, and instead the stormwater floods into resident properties and stand on the road surface for extended periods.

The proposed drainage improvements and increase of roadway width on Heywood Street would increase the overall capacity of stormwater management in the area of Heywood Street. The proposed underground line that runs across Robert Garza Street would convey water out of the Heywood Street neighborhood. This would improve resident health and safety and protect property and infrastructure by lessening the risk of flooding and standing water.

The project has a beneficiary total of 301 residents in Cameron County, which has 421,666 residents, while the population of the 2018 South Texas Floods Eligible Area is 1,317,814. The median household income in the project beneficiary area is \$67,499.50, greater than Cameron County's median income of \$38,758.00, and greater than the 2018 South Texas Floods Eligible Area's Floods Eligible Area's median income of \$40,092.00. The poverty rate in the project beneficiary area is 26.21%, less than Cameron County's rate of 28.88%, and less than the eligible area's poverty rate of 29.23%.

The project beneficiary area population is 83.32% Hispanic or Latino origin, less than Cameron County's 89.66% and less than the percentage for the 2018 South Texas Floods Eligible Area of 91.00%. The Native Hawaiian and Other Pacific Islander percentage for the project beneficiary area is 0.00% and less than the 2018 South Texas Floods Eligible Area's rate of 0.84%. In the project beneficiary area, 25.68% of households are occupied by a female householder with no spouse or partner present, less than Cameron County at 30.35% and less than the 2018 South Texas Floods Eligible Area at 29.77%. The project beneficiary area's households are 5.93% occupied by female householders with no spouse or partner present and their own children in the household under 18, less than Cameron County's percentage of 10.62% and less than the 2018 South Texas Floods Eligible Area's percentage of 10.92%. The project beneficiary area's households are 14.12% occupied by female householders living alone, greater than Cameron County at 10.99%, and greater than the 2018 South Texas Floods Eligible Area are 9.75% occupied by female householders over the age of 65 with no partner or spouse present, making it greater than Cameron County and greater than the 2018 South Texas Floods Eligible Area, which are at 6.12% and 5.23% respectively.

The project beneficiary area is comprised of 16.75% households that are occupied by a male with no spouse or partner present, greater than Cameron County's percentage of 13.97% and greater than the 2018 South Texas Floods Eligible Area's percentage of 13.22%. The project beneficiary area's households are 2.32% occupied by a male householder with no spouse or partner present who have their own children in the household under 18, greater than Cameron County, which is at 1.74% and greater than the 2018 South Texas Floods Eligible Area's 1.41%. Within the project beneficiary area, 7.81% of households are occupied by a male living alone, which is less than Cameron County's 8.10% and less than the 2018 South Texas Floods Eligible Area's percentage

of 7.89%. The project beneficiary area's households are 0.75% occupied by a male householder over the age of 65 with no partner or spouse present, which is less than Cameron County at 3.17% and less than the 2018 South Texas Floods Eligible Area at 2.63%.










### City of Alamo – Flood Improvements, Duranta Ave. - \$937,285.00

This project provides an area benefit within the City of Alamo, benefitting 60.22% LMI persons, therefore meeting the LMI national objective. The project area's LMI beneficiary percentage is greater than the City of Alamo's LMI percentage of 48.70%, greater than Hidalgo County's LMI percentage of 54.86%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

The City of Alamo will perform flood and drainage improvements in the central area known as the Duranta Avenue area. Improvements will include the construction of approximately a 2.50-acre detention pond with excavation, new inlets and approximately 1,400 linear feet (LF) of 24-inch pipes to collect the stormwater. Improvements will also include 18-inch pipe which will discharge approximately 1500 linear feet (LF) to Expressway 1-2. The objective of this work is to alleviate the severe flooding problems in a central neighborhood of the City of Alamo and to increase the capacity for stormwater storage and runoff velocity.

The target for the 2.50-acre detention pond appears to be on school property. It is fenced adjacent to the school but does appear to be fenced separately from the playgrounds or other outdoor areas.

The project has a beneficiary total of 1,209 within Hidalgo County, which has 855,176 residents, while the population of the 2018 South Texas Floods Eligible Area is 1,317,814. The median household income in the project beneficiary area is \$38,440.49, less than Hidalgo County's median income of \$40,014.00, and less than the 2018 South Texas Floods Eligible Area's median income of \$40,092.00. ### City of Donna – Sewer Improvements – \$1,000,000.00

This project provides city-wide benefit for the city of Donna, benefitting 56.40% LMI persons, therefore meeting the LMI national objective. The project's LMI beneficiary percentage is greater than Hidalgo County's LMI percentage of 54.86%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

The City of Donna will install five individual, affixed, emergency backup pumps at five individual lift stations located strategically throughout the city to enhance recovery efforts in the event of loss of power:

- Lift Station #2 Located on the East side of 18<sup>th</sup> Street, between Folsom Street and N. Canal Street;
- Lift Station #4 Located on the Northeast corner of the intersection at Fordyce Avenue and FM 493;
- Lift Station #5 Located on the Southeast corner of the intersection at FM 493 and Wood Avenue;
- Lift Station #7 Located on the Southwest corner of the intersection at Fordyce Avenue and S. 5<sup>th</sup> Street; and
- Lift Station #9 Located on the South side of North Avenue, between N. 7<sup>th</sup> Street and N. 6<sup>th</sup> Street

### City of Edinburg – Chapin Pumps Rehabilitation Drainage Improvements Project - \$1,000,000.00

This project provides an area benefit within the City of Edinburg, benefitting 55.71% LMI persons, therefore meeting the LMI national objective. The project area's LMI beneficiary percentage is greater than the City of Edinburg's LMI percentage of 46.90%, greater than Hidalgo County's LMI percentage of 54.86%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

The Chapin Pumps Rehabilitation Drainage Improvements Project involves designing and installing new pumps and rehabilitating the existing pump station and gates. The project will mitigate flooding within the service area by discharging floodwaters to the nearby Chapin Pond. Chapin Pond is a detention pond that serves approximately 670 acres of residential, commercial, and underdeveloped land and is vital in providing flood detention services to critical city and regional facilities.

Currently, the pump station reroutes stormwater from the storm sewer line flowing north along Sugar Road into Chapin Pond. Once the storm sewer system downstream of the detention pond has enough capacity, two gravity outfall pipes discharge into the storm sewer along Chapin Road. The pump station is currently not operational since the inoperative, unusable, pumps were removed. As a result, Chapin Pond is not working at its maximum capacity due to the lack of pumps. As demonstrated during the 2018 South Texas Floods, this has created an adverse impact, including up to several feet of flooding in some areas and infiltration of floodwaters in the sanitary sewer system.

The newly designed pumps and rehabilitated existing pump station and gates aim to mitigate flooding within the service area. The pumps will allow stormwater to be discharged into the pond and provide relief to the storm sewer system upstream and downstream of the detention pond as well as utilize the total storage capacity of Chapin Pond. The project's impacts include but are not limited to reducing: the backwater effect within the storm sewer system upstream of Chapin Pond, the risk of flood damages and injuries to infrastructure and citizens, and the burden on emergency services during and after flood events.

The Chapin Pumps Rehabilitation Drainage Improvements Project has a beneficiary total of 1,750 residents in Hidalgo County, which has 855,176 residents, while the population of the 2018 South Texas Floods Eligible Area is 1,317,814. The median household income in the project beneficiary area is \$33,408.41, less than Hidalgo County's median income of \$40,014.00, and less than the 2018 South Texas Floods Eligible Area's median income of \$40,092.00. The poverty rate in the project beneficiary area is 24.37%, less than Hidalgo County's rate of 29.69%, and less than the eligible area's poverty rate of 29.23%.

The project beneficiary area is 2.93% Black or African alone, greater than Hidalgo County's percentage of 0.42% and greater than the 2018 South Texas Floods Eligible

Area's percentage of 0.42%. The American Indian and Alaska Native alone percentage for the project beneficiary area is 0.22%, which is greater than Hidalgo County and greater than the 2018 South Texas Floods Eligible Area, who are at 0.06% and 0.09% respectively. The project beneficiary area is 0.30% Asian alone, less than Hidalgo County's percentage of 0.94% and less than the 2018 South Texas Floods Eligible Area's rate of 0.84%. The Native Hawaiian and Other Pacific Islander percentage for the project beneficiary area is 0.00%, which is equal to Hidalgo County at 0.00% and less than the 2018 South Texas Floods Eligible Area floods Eligible Area at 0.01%. The project beneficiary area has zero census tracts that are designated as a R/ECAP. Hidalgo County has a total of 41 census tracts that are designated as R/ECAPs.

As the Hidalgo County seat and an anchor for Texas' fifth largest metropolitan area, Edinburg is home to critical infrastructure integral to the region, state and nation's security, economic security, and public health. Edinburg is centrally located in the 4-county Rio Grande Valley region in deep South Texas and is less than 15 miles from the U.S.-Mexico border. This project's service area is home to several critical infrastructure key assets that will help the City of Edinburg sustain the ability to conduct mission-essential functions during an actual disaster event.

The largest element in the community is the University of Texas Rio Grande Valley (UTRGV) campus. Located approximately two blocks from the pump station, the campus is well maintained and fully developed. There is a large baseball field less than two blocks from the site that is home to the UTRGV baseball team.

The houses that are closest to the pump station are large, gated properties, which is atypical for the area. There is an open field across the street. There is a flood reservoir adjacent to the pump station that is used as a water feature with a surrounding walking track.

Other housing looks to include older student housing apartments and smaller single family brick housing. There are retail and commercial facilities on University Avenue. Also nearby is the Area Education Service Facility.

# City of La Villa – City of La Villa East Lateral Southern Weir – \$1,000,000.00

This project provides city-wide benefit for the City of La Villa, benefitting 61.40% LMI persons, therefore meeting the LMI national objective. The project's LMI beneficiary percentage is greater than Hidalgo County's LMI percentage of 54.86%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

This project includes improvements to the existing weir that provides regional flood control to the City of La Villa and surrounding areas south of West State Highway 107 between Mile 2 West and South Mike Chapel Road. Homes were under water for days after the 2018 South Texas Floods. The City of La Villa was one of the hardest hit communities in the area and requires robust investments to fix its drainage. The project is designed to mitigate flooding and will result in less homes being affected by flooding. The City of La Villa believes that continuing to build partnerships at all levels will allow for new and innovative solutions that will lead to an increase in affordable housing units.

La Villa is a community of 2,720 residents in Hidalgo County, which has 855,176 residents, while the population of the 2018 South Texas Floods Eligible Area is 1,317,814. ## City of Mercedes – South Mercedes Lateral Improvements Project – Phase 3 - \$1,000,000.00

This project provides an area benefit within the City of Mercedes, benefitting 57.86% LMI persons, therefore meeting the LMI national objective. The project area's LMI beneficiary percentage is less than the City of Mercedes's LMI percentage of 63.10%, greater than Hidalgo County's LMI percentage of 54.86%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

The City of Mercedes and Hidalgo County Drainage District No. 1 are proposing to enhance the drainage of the City of Mercedes, specifically the South Mercedes Lateral, near the intersection of West Levy Road and Del Rio Road. The drainage district and the City of Mercedes are the local governmental entities responsible for the drainage for the City of Mercedes. The proposed project presents a unique opportunity to put infrastructure in the ground that will provide real solutions to flooding of housing and businesses in one of the most heavily urbanized areas in the City of Mercedes.

The South Mercedes Lateral Improvements Project is a large-scale project that has been in development for several years. The Hidalgo County Drainage District has already invested millions of bond dollars to make improvements associated with the South Mercedes Lateral. Additional phases will be necessary to complete the project.

## City of Mission – La Cuchilla Drainage Project – \$997,236.75

This project provides an area benefit within the City of Mission, benefitting 72.07% LMI persons, therefore meeting the LMI national objective. The project area's LMI beneficiary percentage is greater than the City of Mission's LMI percentage of 44.00%, greater than Hidalgo County's LMI percentage of 54.86%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

This project will improve drainage in the area by creating a four-acre detention pond south of La Cuchilla Circle through excavation, clearing, and establishing embankments and other related activities. The project will also include approximately 375 linear feet of 24-inch reinforced concrete pipe just south of Mile 1 South Road, approximately 190 linear feet of 60-inch reinforced concrete pipe, and approximately 165 linear feet of 54-inch reinforced concrete pipe from West B Street to La Cuchilla Circle, eastward alongside South Olmo Street.

# City of Palmview - Riverside Drainage Project - \$540,475.61

This project provides an area benefit within the City of Palmview, benefitting 58.38% LMI persons, therefore meeting the LMI national objective. The project area's LMI beneficiary percentage is greater than the City of Palmview's LMI percentage of 50.70%, greater than Hidalgo County's LMI percentage of 54.86%, and greater than the 2018 South Texas Floods eligible area's LMI percentage of 54.50%.

The proposed drainage improvements consist of installing four storm inlets, five manholes, approximately 1,156 linear feet of underground storm drainpipe system, 1,320 of drainage ditch improvements, an expanded detention pond, and all associated appurtenances.

Currently, stormwater in the Riverside Estates neighborhood drains from north to south via overland flow from Bougainvillea Street to the cul-de-sacs for Azucena, Claveles, Magnolia, and Tulipan Streets. Stormwater is then conveyed into grass swales which capture and convey stormwater further south through the existing lots into a drainage easement. The drainage swales are not conveying stormwater downstream as designed. Structures are located within the drainage easement causing obstructions to stormwater flow and no positive storm drain outfall is available in the area.

Azucena, Claveles, Magnolia, and Tulipan Streets flood during storm events beginning at the culde-sacs and then travel north within the streets and the surrounding lots towards Bougainvillea Street. Storm water has to be pumped out of the streets with a City of Palmview mobile pump until the limits of the stormwater are no longer negatively impacting the community.

The proposed drainage improvements consist of installing storm inlets at the end of each cul-desac. Stormwater captured via the inlets will be conveyed through an underground storm drainpipe system which drains into an existing drainage easement at the south end of the subdivision towards the east to a proposed detention pond outfall location. The ultimate outfall from the detention pond will be into a roadside ditch located on the west side of Silver Spur Lane at a controlled release rate to prevent any adverse drainage impacts to the existing ditch.

The project's LMI beneficiary percentage is greater than Hidalgo County's percentage of 54.86% and greater than the 2018 South Texas Floods Eligible Area's LMI percentage of 54.50%.

The City of Progreso is proposing to enhance the City's primary drainage outfall system by making a series of improvements that will create regional flood control for the city. The primary task will entail creating new systems and enhancing existing systems primarily by means of excavation to create storm-water retention reservoirs. This part of the plan creates two detention ponds, has crossing designs for drainage, completes excavation of existing ditches, and works with culverts according to the engineering map.

Progreso is a community of 5,905 residents in Hidalgo County, which has 855,176 residents, while the population of the 2018 South Texas Floods Eligible Area is 1,317,814. The median household income of Progreso is \$52,500.00, greater than Hidalgo County's median income of \$40,014.00, and greater than the 2018 South Texas Floods Eligible Area's median income of \$40,092.00. The poverty rate in Progreso is 20.32%, less than Hidalgo County's rate of 29.69%, and less than the eligible area's poverty rate of 29.23%.

Progreso's population is 99.97% Hispanic or Latino origin, greater than Hidalgo County's 92.18% and greater than the percentage for the 2018 South Texas Floods Eligible Area of 91.00%. The population of Progreso is 0.03% white alone, less than Hidalgo County's white alone percentage of 6.14% and less than the 2018 South Texas Floods Eligible Area's percentage of 7.41%. Progreso is 0.00% Black or African alone, less than Hidalgo County's percentage of 0.42% and less than the 2018 South Texas Floods Eligible Area's percentage of 0.42% and less than the 2018 South Texas Floods Eligible Area's percentage of 0.42% and less than the 2018 South Texas Floods Eligible Area's percentage of 0.42% and less than the 2018 South Texas Floods Eligible Area, who are at 0.06% and 0.09% respectively. Progreso is 0.00% Asian alone, less than Hidalgo County's percentage of 0.94% and less than the 2018 South Texas Floods Eligible Area's rate of 0.84%. The Native Hawaiian and Other Pacific Islander percentage for Progreso is 0.00%, which is equal to Hidalgo County at 0.00% and less than the 2018 South Texas Floods Eligible Area at 0.01%. In Progreso, 0.00% of the population is two or more races, less than Hidalgo County, which is at 0.12%, and less than the 2018 South Texas Floods Eligible Area at 0.01%.

Native born national origin residents from within the United States is 71.31% in Progreso, less than Hidalgo County at 71.87%, and less than the 2018 South Texas Floods Eligible Area, which is at 73.74%.

Progreso is 52.41% male, greater than Hidalgo County's percentage of 48.98% and greater than the 2018 South Texas Floods Eligible Area's percentage of 48.86%. Progreso is 47.59% female, less than the 51.02% of Hidalgo County and less than the 2018 South Texas Floods Eligible Area's female percentage of 51.14%.

The households in Progreso are comprised of 76.50% married couple families, which is greater than Hidalgo County's 53.76% and greater than the 2018 South Texas Floods Eligible Area's percentage of 53.08%. The percentage of households in Progreso that are occupied by married couples who have their own children in the household under 18 is 36.04%. This is greater than Hidalgo County's percentage of 27.63% and greater than the 2018 South Texas Floods Eligible Area's percentage of 26.29%. Progreso's households are 0.00% cohabitating households, less than Hidalgo County's percentage of 4.08% and less than the 2018 South Texas Floods Eligible Area's 3.92%. Households with cohabitating couples who have their own children in the household under 18 comprise 0.00% of households in Progreso, which is less than Hidalgo County's 2.10% and less than the 2018 South Texas Floods Eligible Area's than the 2018 South Texas Floods Eligible Area's 2.00%.

In Progreso, 19.48% of households are occupied by a female householder with no spouse or partner present, less than Hidalgo County at 29.45% and less than the 2018 South Texas Floods Eligible Area at 29.77%. Progreso's households are 7.83% occupied by female householders with no spouse or partner present and their own children in the household under 18, less than Hidalgo County's percentage of 11.26% and less than the 2018 South Texas Floods Eligible Area's percentage of 10.92%. Progreso's households are 4.43% occupied by female householders living alone, less than Hidalgo County at 8.56%, and less than the 2018 South Texas Floods Eligible Area at 9.55%. The households in Progreso are 2.32% occupied by female householders over the age of 65 with no partner or spouse present, making it less than Hidalgo County and less than the 2018 South Texas Floods Eligible Area, which are at 4.70% and 5.23% respectively.

Progreso is comprised of 4.02% households that are occupied by a male with no spouse or partner present, less than Hidalgo County's percentage of 12.71% and less than the 2018 South Texas Floods Eligible Area's percentage of 13.22%. Progreso's households are 0.00% occupied by a male householder with no spouse or partner present who have their own children in the household under 18, less than Hidalgo County, which is at 1.21% and less than the 2018 South Texas Floods Eligible Area's 1.41%. Within Progreso, 0.00% of households are occupied by a male living alone, which is less than Hidalgo County's 7.68% and less than the 2018 South Texas Floods Eligible Area's percentage of 7.89%. Progreso's households are 0.00% occupied by a male householder over the age of 65 with no partner or spouse present, which is less than Hidalgo County at 2.31% and less than the 2018 South Texas Floods Eligible Area at 2.63%.


In Progreso, 55.86% of households have one or more people under the age of 18. This is greater than Hidalgo County, which is at 49.25% and greater than the 2018 South Texas Floods Eligible Area at 47.61%. The percentage of households within Progreso that have one or more people of 65 or older is 28.54%, which is greater than Hidalgo County's 26.36% and greater than the 2018 South Texas Floods Eligible Area's 28.08%.

The percentage of persons with a disability in Progreso is 15.85%, greater than Hidalgo County's 12.95%, and greater than the 2018 South Texas Floods Eligible Area's percentage of 12.87%.

Progreso has one census tract that is designated as a R/ECAP. Hidalgo County has a total of 41 census tracts that are designated as R/ECAPs.

There are wood and brick houses in the area, as well as many smaller homes. The area also has a few larger homes in the general area. The houses are generally in good shape. There are neighborhoods, but they do not seem to be heavily concentrated around the construction sites. At the second drainage field near Highway 1015, there are some newer homes, but the area is largely open fields. Much of the project work appears to be through open fields, although it does run adjacent to housing.






