#### **MINUTES**

Special Called Meeting of the School Land Board Tuesday, August 19, 2025, 10:00 A.M. 1700 N. Congress Avenue, Room 170, Austin, TX 78701

Chairwoman Buckingham called the meeting to order at 10:00 A.M. and the Chair declared a quorum present.
