## Local Infrastructure Program Method of Distribution Amendment Detail

The COG is required to prepare a method of distribution amendment for the Local Infrastructure Program funds between the eligible cities and counties. The GLO has directed the COG to use a direct allocation technique based on objective and verifiable data. The distribution should be based on, but not limited to, unmet need tied back to Hurricane Harvey damages.

## Reallocation Summary

The following is a summary of the reallocation process of funds, including entities that have declined funds, entities that are receiving reallocated funds, and eligible activities.

Should a city decline or be unable to utilize the funding allocated under this Method of Distribution, H-GAC proposed a two-step reallocation methodology.

Ten entities have declined or de-obligated funds totaling \$2,305,505.00 available to reallocate. H-GAC proposed these funds be first offered to the county of origin for each of the ten entities, as listed below.

**Low- and Moderate-Income Requirement**

Below is an explanation of how the method of distribution meets the 70 percent low- and moderate-income (LMI) requirement for each program. This means that 70 percent of the funds must benefit areas that are 51% or more LMI persons with incomes below 80% of the Area Median Income (AMI).

Per requirements of the State of Texas Plan for Disaster Recovery: Hurricane Harvey June 25, 2018, submitted to the United States Department Housing and Urban Development (HUD) by the Texas General Land Office (GLO), at least 70% of the program funds will benefit low- and moderate-income (LMI) persons. All entities will be required to follow established rules and regulations related to the funding received.

## Citizen Participation

Below is a description addressing how the COG complied with their Citizen Participation Plan regarding citizen and non-governmental organization outreach, and any additional efforts exceeding GLO minimum public participation requirements:

Beyond the minimum requirements that the GLO has outlined in the contract, H-GAC implemented the additional tactics listed below to increase overall public participation:

- Distributed electronic flyers and asked community organizations to share information with their audiences
  - H-GAC sent a one-page flyer that contains all the information about the meetings to identified stakeholders so they could either forward the information to their membership or print off the material to post on a bulletin board or high-traffic area at their location.
- Purchased legal ads in English, Spanish, Vietnamese, and Mandarin newspapers across the region.
- Sent direct emails to identified stakeholders (i.e., elected officials and staff, fair housing groups, long term recovery groups etc.)
  - In addition to direct emails to elected officials and staff representing jurisdictions across the 13-county region, H-GAC also invited the following groups to attend the public planning meeting on November 9 to provide feedback and ask questions, to attend the public hearing on December 6, and to provide comment in writing or verbally. State and Federal Elected Officials, Office of Emergency Management Staff, Regional Flood Management Committee Members, and Soil and Water Conservation staff.
  - To gain additional perspective on fair housing and civil rights issues in the region, H-GAC also invited the following groups to attend the public planning meeting on November 9 to provide feedback and ask questions, to attend the public hearing on December 6, and to provide comment in writing or verbally. Community Development Directors and Staff, Faith-based Organizations, Neighborhood and Community Improvement Organizations. Long-Term Recovery Groups, Housing Authorities, Housing Advocacy Groups, Homeless Services Organizations, Food Banks, County Health Districts, and other non-profit organizations, including MMHR, NAACP, United Way, Habitat for Humanity, Area Agency on Aging, Meals on Wheels, and LULAC.
- Promoted the public planning meeting, public hearing, and comment period through H-GAC’s external newsletters, the Community and Environmental Planning Update and the Regional Focus.
- Promoted the public planning meeting, public hearing, and comment period by posting to community calendars and newsletters.
- Promoted the public planning meeting, public hearing, and comment period via social media posts (i.e., Facebook, LinkedIn, Instagram, and Twitter).

The Americans with Disabilities Act (ADA) stipulates that meetings involving the public must be accessible to individuals with disabilities. Meetings must comply with all applicable ADA accessibility requirements and should also be conducted in such a way that all participants can participate in an equal and meaningful way. H-GAC fully complies with these requirements through its internal policies and procedures. H-GAC facilitates public participation for individuals with disabilities using the following guidelines:

The public planning meeting was held online, and the public hearing was held online and in person. H-GAC hosted the public planning meeting on the Zoom platform and hosted the public hearing at its offices in Houston and via the Zoom platform to allow participants to participate in person or to join via desktop, mobile phone, or dial-in should they have limited internet connectivity.

All public outreach efforts attempt to solicit as much feedback as possible by making meeting times and locations accessible and by working with organizations that provide public-focused services.

Additionally, H-GAC provided multiple methods in which stakeholders could provide feedback including not only verbally and in chat at public meetings, but also via email, voicemail, and web portal until 5 p.m. December 15, 2022.

Recognizing that the 13-county region is diverse, and using current census data, H-GAC provided Spanish, Vietnamese, and Mandarin interpreters at all public meetings and hearings so participants can actively listen, ask questions, or engage in dialogue with H-GAC staff. American Sign Language interpreters were present throughout a public planning meeting on November 9, and closed captioning was enabled online during the public hearing on December 6. The availability of interpreters was advertised in all outreach materials. Any additional languages could be requested 48 hours in advance by calling Sara Hart at 713-993-4560 or Sara.Hart@h-gac.com.

## **Affirmatively Furthering Fair Housing Statement**

All subrecipients will certify that they will affirmatively further fair housing (“AFFH”) in their grant agreements and will receive GLO training and technical assistance in meeting their AFFH obligations. Additionally, all project applications will undergo AFFH review by GLO before approval of projects. Such review will include assessment of a proposed project’s area demography, socioeconomic characteristics, housing configuration and needs, educational, transportation, and health care opportunities, environmental hazards or concerns, and all other factors material to the AFFH determination. Applications should show that projects are likely to lessen area racial, ethnic, and low-income concentrations, and/or promote affordable housing in low-poverty, nonminority areas in response to natural hazard related impacts.

# RESOLUTION

AUTHORIZING THE EXECUIVE DIRECTOR TO SUBMIT THE AMENDED METHOD OF DISTRIBUTION AND ALL RELATED DOCUMENTS FOR COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY LOCAL INFRASTRUCTURE PROGRAM FUNDS TO THE TEXAS GENERAL LAND OFFICE.

WHEREAS, Hurricane Harvey directly impacted the Houston-Galveston Area Council (H-GAC) region with devastating flooding, causing extensive damage to local public infrastructure; and

WHEREAS, Congress appropriated Community Development Block Grant Disaster Recovery funds to Texas through the Department of Housing and Urban Development (HUD) to be administered by the Texas General Land Office (GLO); and

WHEREAS, H-GAC developed a Method of Distribution (MOD) for allocating \$129,751,767 in Local Infrastructure Program funds to local governments under GLO's State Action Plan in response to our region's impacts during Hurricane Harvey; and

WHEREAS, \$2,305,505 of the allocated funds were declined or de-obligated by local communities, and an amendment to the MOD is required to formally include the reallocation methodology developed by the H-GAC Board in 2018; and

WHEREAS, taking into account public comment, H-GAC presented an amended MOD reallocation methodology at H-GAC's Board of Directors meeting on January 17<sup>th</sup>, 2023, which was duly posted and conducted in accordance with the Texas Open Meetings Act;

NOW, THEREFORE BE IT RESOLVED BY THE H-GAC BOARD OF DIRECTORS:

1. THAT the amended Method of Distribution of the H-GAC region is hereby approved; and
2. THAT the Executive Director of the Houston-Galveston Area Council is duly authorized to execute the Method of Distribution and all other supporting documents; and
3. THAT this is a true and correct copy of the resolution reciting the actions and approvals given by the Board of Directors at its meeting on January 17<sup>th</sup>, 2023.

The utilities go out often in this area and I have to prime this well with at least 20 gallons of water. I have had to go days without water. Please help to replace my pump.

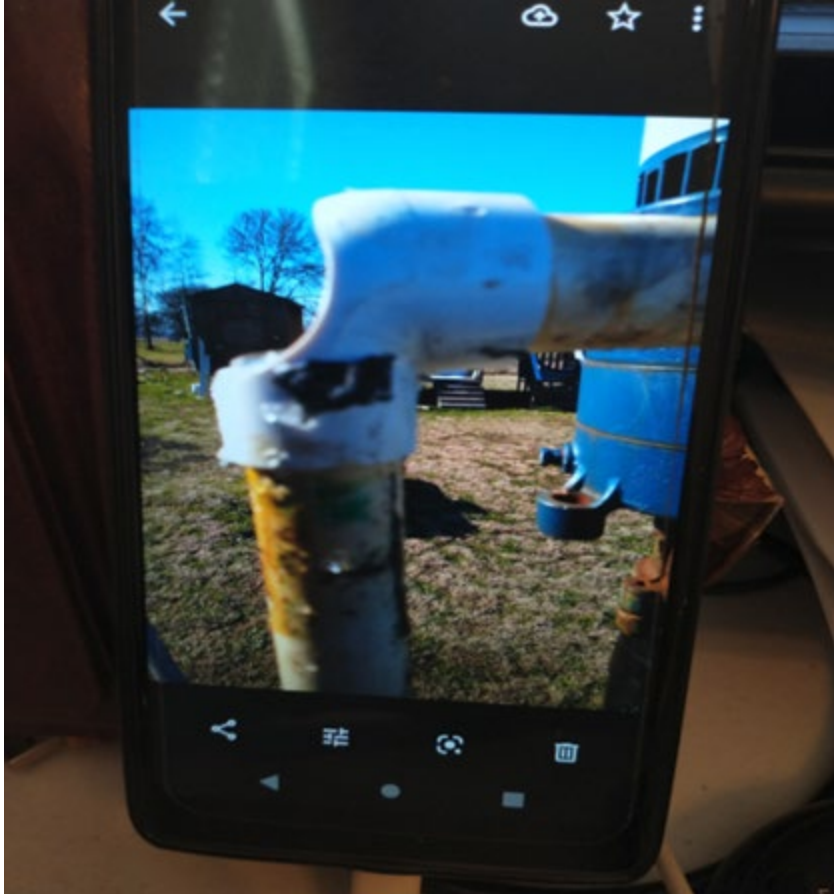
This well is ruining my appliances. When it’s cold weather pipes freeze and burst because it’s too high in the air. My neighbors do not have this problem.

H-GAC hosted a public planning meeting November 9, 2022, to provide information, answer questions, and take feedback. H-GAC sought public comment on the reallocation amendment. Public comment was accepted by email, phone, postal mail, through an online portal, and at a public hearing on December 6, 2022. No changes were made following the public comment period ending December 15, 2022.

At their regularly scheduled meeting on January 17, 2023, the H-GAC Board of Directors approved the amendment for submittal to the Texas General Land Office for approval. This meeting was open to the public.

Subsequent to the Board approval, H-GAC confirmed that the counties of origin indicated in step 1 of the reallocation process would all accept the reallocated funds, eliminating the need for step 2. The final reallocation of funds is represented by the amounts and recipients indicated in the table for Step 1.
