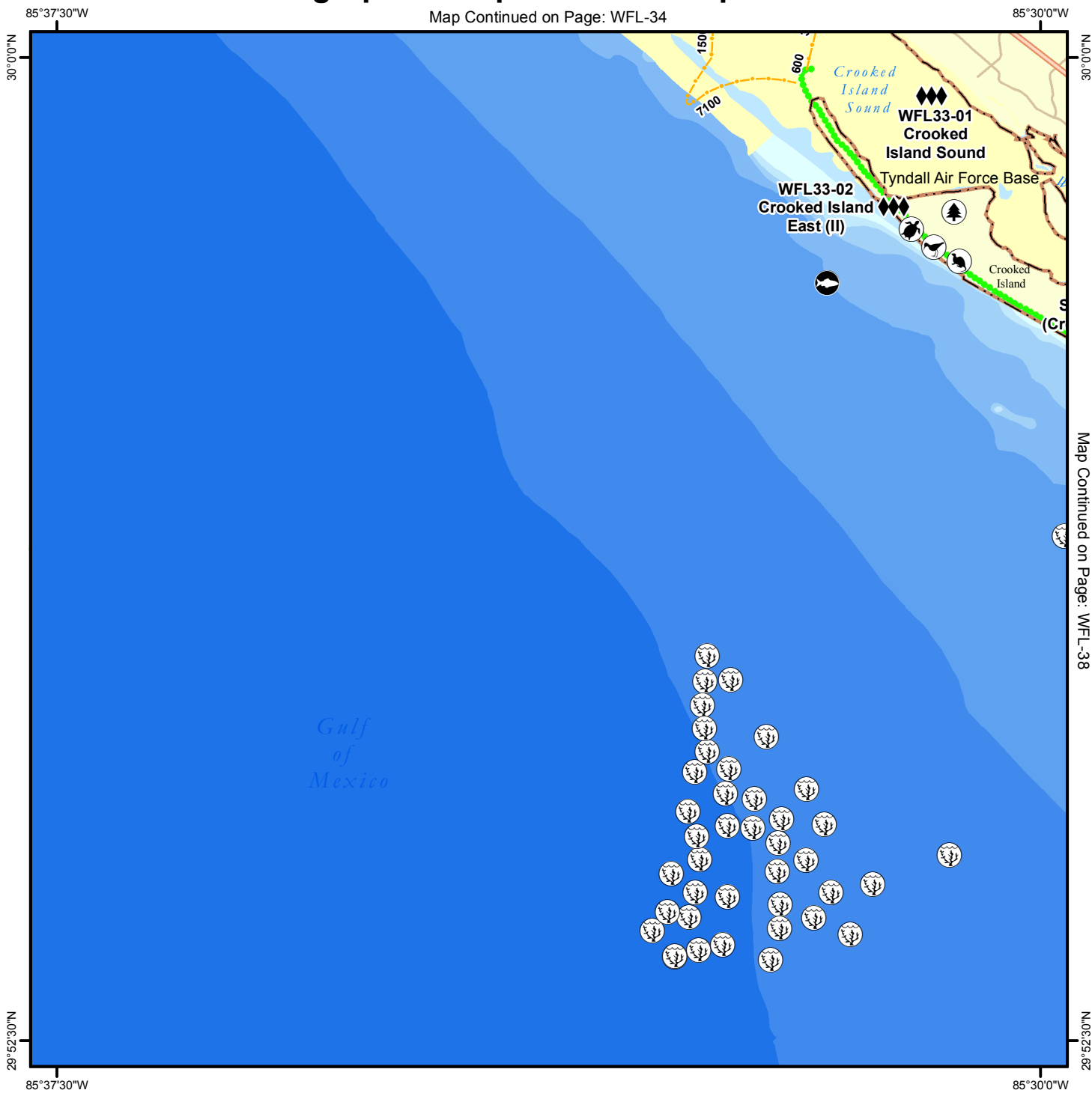


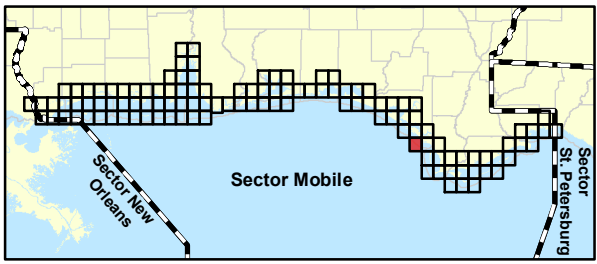
Geographic Response Plan Map: WFL-33
